ABSTRACT

Community participation is very important in realizing the construction of the Taqwa Muhammadiyah Mosque so that the development planning can be felt by every level of society. The development carried out in Gosong Telaga, North Singkil District, Aceh Singkil Regency, is currently progressing well. This can be seen from the contribution of community participation in the development planning process, where the development carried out has responded to community needs. Considering the importance of community participation in the development planning process, it is necessary to study efforts to increase community participation in Gosong Telaga, North Singkil District, Aceh Singkil Regency to realize the construction of the Taqwa Muhammadiyah Mosque. This study aims to identify the form and level of community participation in the development planning process. More specifically, what is meant by a mosque here is a place where congregational prayers are held, whether Friday prayers are held there or not.

Indonesia is one of the countries in the world where the majority of the population is Muslim. From this phenomenon, in terms of quality, there are a lot of them. Therefore, the most important means of strengthening Islam is building a mosque and carrying out various activities in the mosque, especially activities that

have an Islamic nuance. Like Muslims themselves today, mosques generally function as a place for five daily prayers and religious guidance such as weekly and monthly wirid, in this function the community receives religious guidance. In this case, it is hoped that it can increase the faith of Muslims themselves. To carry out the function of a mosque in the midst of social life, it is necessary to build a mosque to facilitate the programs that will be carried out by the mosque management, therefore community participation is very important in mosque construction activities by the local community. Community participation is the participation of the community in mosque construction activities which are carried out together and have a spirit of cooperation in its implementation. Community participation in the construction of mosques is not only in the form of financial donations but is understood in a broader sense, namely, participation is participation starting as community from the planning, implementation, monitoring and utilization stages of development. B. LITERATURE REVIEW

Community participation

The meaning of participation is always associated or synonymous with participation. A scientist named Davis put forward his definition of participation which was quoted by Santoso (1988:13) states: "Participation can be defined as mental or thought or moral or feeling involvement in a group situation that encourages you to contribute to the group to achieve goals and also take responsibility for the efforts concerned." Based on the opinion above, participation is not based on physical involvement in work but involves a person's involvement so that it will give rise to great responsibility and contribution to the group. Participation is participation, attention and contributions given by participating groups, in this case, the community (Pasaribu, 1992:17). To grow and mobilize the spirit of participation, prerequisites are needed that can generate social energy in society.

Understanding Development

Development Planning Concept

The idea of establishing the Takwa Muhammadiyah Mosque in Gosong Telaga

Indonesia is a country where more than 90% of the population is predominantly Muslim, so the need for mosque infrastructure is very necessary to support the worship of Muslims in particular. Initially, mosques were places of activity for the Muslim community. In Islamic history, the Rasulullah SAW Mosque played many social functions in addition to its sacred function.

During the time of the Prophet, he and his companions made their mosque prosperous not only for congregational prayers. However, it also functions as a place for consultation on religious matters and also a place for deliberation in solving worldly problems of the ummah. All kinds of problems ranging from agriculture and the people's economy, to social inequalities in society are also solved in the mosque. It is as if the mosque is a hall or meeting room for the community and its leaders. Until the information center is in the mosque. During the time of the Prophet, the mosque also became a center for education, teaching and takhasu, a kind of college with one class. In fact, according to one history, the mosque at that time was a place for war training. And also a refugee shelter.

The idea of establishing the Gosong Telaga Muhammadiyah Takwa Mosque cannot be separated from the theological basis for the establishment of the

Muhammadiyah Association which was founded by K.H. Ahmad Dahlan in Kauman Village, Yogyakarta on 18 November 1912 (8 Dzulhijjah 1330 H). namely the word of Allah SWT (O.S. Ali-Imran/3: 104) which reads in meaning:

and let there be among you a group of people who call to virtue, enjoin what is good and forbid what is evil, they are the lucky ones.

Aims & Objectives of the Establishment of the Gosong Telaga Muhammadiyah Takwa Mosque.

In general, every establishment within the Muhammadiyah organization is always linked to Article 6 of the Muhammadiyah Articles of Association which states that the aim and objective of Muhammadiyah are to uphold the Islamic religion so that a true Islamic society can be realized (primarily, just and prosperous, which is blessed by Allah SWT). The mosque is part of one of the concrete manifestations of or one part of the main community development forum.

Upright: Means making and trying to keep it upright and not tilt, let alone collapse. All of this can be realized when something that is established is placed on a solid and solid foundation, basis or principle, held tightly, defended, defended and fought for with full consequences.

To uphold: means to carry or uphold above all things, heed and respect them. Islam: namely the religion revealed to His Messengers from the Prophets Adam, Noah, Abraham, Moses, Jesus to Muhammad as God's guidance and mercy to mankind throughout the ages, as well as guaranteeing the ultimate worldly/ukhrawi welfare.

Manifest: means becoming a reality of its existence or existence. Primary society: namely a society that always pursues virtue and benefits for the benefit of human life, a society that always has a respectful attitude towards Allah SWT, heeds with sincerity towards His teachings and respects fellow human beings as creatures of Allah SWT who have the dignity of ahsanu taqwim. Fair and prosperous: fulfilling physical and spiritual needs.

According to Djarnawi Hadikusuma, these simple words have a very deep and broad meaning. This means that if Muslims are weak and backward because they do not understand the true teachings of Islam, Muhammadiyah expresses and emphasizes pure Islamic teachings, encouraging Muslims to study them in general. Scholars teach them interesting atmospheres and things that encourage them to learn in a more advanced way.

Apart from that, the establishment of the Gosong Telaga Muhammadiyah Takwa Mosque was also driven by the enthusiasm of friends in the organization, both in the leadership of Muhammadiyah Singkil and members in Gosong Telaga itself, to develop the Muhammadiyah organization in Aceh Singkil Regency within the district scope and specifically in Gosong Telaga village. North Singkil District, which incidentally does not yet have a Muhammadiyah Takwa Mosque.

- d. Participation in development means pushing towards development that is compatible with human dignity. Social justice and national justice and preserving nature as a living environment for humans and future generations. Suryono's opinion (2001:124) is that participation is the participation of the community in development, taking part in development activities and taking part in utilizing and enjoying the results of development.

Concentrating on the charred lake community in the construction of the Taqwa Muhammadiyah Mosque, they were very enthusiastic, especially in the construction of the Taqwa Mosque which was carried out using a development approach with a local spirit.
